The Rule 18(7) of the TOR, 2013

(7) Any person, aggrieved by the decision of the Election Commission or in case the Election Commission fails to decide the representation within the period provided in sub-rule (6), may, within three days of decision by the Election Commission or, as the case may be, on expiry of limitation of the Election Commission under subrule(6), make an appeal to the Regulator who shall decide the appeal within ten days and his decision in this regard shall be final.

The Rule 18(13) of the TOR, 2013

(13) Within two days of decision of the Election Commission or in case the commission fails to decide within the stipulated time provided in sub-rule(12), any candidate, aggrieved by the decision of the Election Commission or, as the case may be, on expiry of limitation of the Election Commission under sub-rule (12), may file an appeal to the Regulator, who shall decide it within seven days and his decision in this regard shall be final.
